GENERAL TERMS

Currency

Financial transactions covered by this Contract will be processed in the US currency. Currency exchanges will occur when you or your partner(s) have set a different default currency in account settings.

Change Notification Period

The Contract can be changed or cancelled with 0-day(s) notification to media partner.

Reversal of Policy

Reversal of performance advertising actions are decided by Walmart and are governed by a max reversal percentage of 100%.

Media Partner Tracking Pixel

Advertiser does NOT allow media partner to fire their tracking pixel when the consumer action is completed.

Maximum Commission Limitation

The seller will not be eligible to receive a commission exceeding 10% off the base referral fee per qualifying item under this program.

Exclusion for Items with Other Discounts

If you are already receiving a discount of 10% or more on the base referral fee for a specific item through another qualifying program, you will not be eligible to receive an additional discount via this program.

No Duplicate Discounts

Under no circumstances will seller receive more than a 10% discount. No duplicate discounts on the referral

fee for the same qualifying item. Only one 10% maximum discount may be applied per qualifying item.
