Walmart Business Addendum to the Walmart Marketplace Retailer Agreement

Walmart Business (https://business.walmart.com) is Walmart's B2B website. Walmart Business is designed to help businesses and organizations save time, money and hassle so they can focus on their missions.

By selling products on Walmart Business, the Retailer agrees to all of the terms and conditions outlined in the Walmart Marketplace Retailer Agreement, in addition to the terms and conditions set forth below.

I. Becoming a Retailer on Walmart Business. By being an active Walmart Marketplace Retailer, Retailer agrees to have their published Walmart Marketplace items sold on Walmart Business (business.walmart.com). If Retailer is invited by Walmart Business to sell on the Walmart Business site, Retailer will be notified and will have the option to opt out as set forth below.

The offer details for any item you set for your published offers (including, but not limited to, Item Price, Available to Sell Inventory, Shipping Fees) on Walmart Marketplace will also be published on Walmart Business, unless Retailer chooses to utilize available tools provided by Walmart (as set forth below) to modify the offer details for Walmart Business. Prices available on Walmart Business will only be visible to verified Walmart Business customers when they log in to their Walmart Business account. If Retailer chooses to lower an Item Price on Walmart Marketplace for consumers and the consumer price becomes lower than the Walmart Business price, the Item Price will automatically be lowered on Walmart Business to match. If Retailer does not agree to the price lowered on Walmart Business to match the consumer offering, Retailer may either choose to remove the item from the Walmart Business site or may choose to opt out of selling on Walmart Business (see Section VI below). Eligible offers may be sold at a higher maximum quantity per order on Walmart Business than the maximum quantity per order allowed on Walmart Marketplace.

- II. Tools to Modify Offer Details on Walmart Business. If Retailer chooses to utilize any available tools provided by Walmart to modify offer details on Walmart Business (including, but not limited to, offering a lower Item Price for Walmart Business, offering volume pricing for Walmart Business, making an offer available to sell only on Walmart Business), Retailer agrees to utilize the tools offered at their own discretion. Retailer agrees to fulfill orders resulting from such offers according to the terms and conditions in the Walmart Marketplace Retailer Agreement.
- **III. Performance.** You must adhere to the same performance standards of the Walmart Marketplace as outlined in the Walmart Marketplace Retailer Agreement. All requirements related to returns, labeling or any other obligations will be consistent with the requirements of the Walmart Marketplace.
- **IV. Orders and Fulfillment.** Walmart Business orders will operate the same for Retailer as the Walmart Marketplace orders. Retailer will follow the same order and fulfillment practices for Walmart Business orders as for Walmart Marketplace orders in the Walmart Marketplace Retailer Agreement.
- **V. Walmart Business Customers.** Retailer understands that Walmart Business customers may include government entities. Suppliers, third-party sellers, and service providers for Walmart shall not

be considered government contractors or subcontractors in connection with the Walmart Marketplace Retailer Agreement.

VI. Removal of Retailer or Items from Walmart Business. Walmart Business reserves the right to exclude any Retailer and/or any item from the Walmart Business site (business.walmart.com). If Retailer chooses to exclude an item(s) from the Walmart Business site, please notify Walmart Business. Please allow up to 30 days for your item(s) to be removed from the site. If Retailer is choosing to remove an item pursuant to Section I above, the item will be removed within three (3) business days.

If Retailer chooses to opt out of selling on Walmart Business, a 30-day notice period is required. Please notify Walmart Business of your decision by following the step-by-step instructions set forth in the "Request to opt out of Walmart Business" in the Seller Help Center.

If Retailer or items are removed from Walmart Business for any reason, Retailer will still be responsible for any obligations in the Walmart Marketplace Retailer Agreement for sales that were completed prior to removal from the site.

VIII. Modification of Addendum. Walmart Business may modify or discontinue this Addendum at any time in its sole discretion. Your continued participation as a Retailer on Walmart Business constitutes acceptance of any such modifications. If you do not agree with any changes, please immediately request to opt out of selling on Walmart Business as described above.
