- Non-Pro Sellers: Receive 10% off your base referral fees for all sales of items newly added to the Repricer.
- Pro Sellers: Receive 15% off your base referral fees for all sales of items newly added to the Repricer.

## **Eligibility Requirements:**

To qualify for the Repricer Referral Fee Incentive:

- Sellers must enroll their items into Walmart's Automated Pricing Tool (Repricer).
